- Exhibitors must set up within the allocated space or spaces paid for. All spaces will be marked.
- No dogs, with the exception of service dogs, are allowed in the buildings.
- Once an exhibitor has been approved and payment has been received, no refunds.
- Exhibitors are requested to donate a piece of art valued at least \$50.00 in lieu of commissions.
